#### STRATEGIC HIGHLIGHTS

This year was a year of new beginnings. We have focused on the 20<sup>th</sup> Anniversary of MABA this year. We have continued to strengthen each of the committees and look for more ways to engage members. We look forward to growth, participation of committees, and more networking opportunities than ever before as we go into 2018.

#### FINANCIAL HIGHLIGHTS

MABA is a financially sound organization through good decisions from the Board of Directors and following its budget each year. We have spent additional funds on marketing and the  $20^{\rm th}$  Anniversary this year.

#### **OPERATING HIGHLIGHTS**

MABA has not grown at the pace that was forecasted for 2017. This is not to say that new members have not joined, but that due to many factors, we have still added approximately 28 new members. We had 73 guests to visit our monthly meetings too. The 20<sup>th</sup> Anniversary of MABA was a vehicle to increase membership. The committee goal is to have 10% of all Meridian Area businesses as members of MABA. This will mean a total of 200 members by the end of 2018.

#### **COMMITTEE ACOMPLISHMENTS**

#### **20th Anniversary Committee**

- The Social Committee combined with the 20<sup>th</sup> Anniversary Committee to plan monthly events to celebrate MABA's history and to increase membership.
- The year kicked off with a Wine Tasting Reception on January 20<sup>th</sup> at Dusty's Cellar. Matt Rhodes, was one of the five Founding Members who created MABA as a business association.
- Facilitated nine monthly MABA Socials with an average of 30 40 people in attendance.
- Worked with Paul Schmidt, UnoDeuce, to produce 2 videos about MABA's 20 years of history and growth as a stellar association.
- Established a new award Lifetime Achievement Award which will be awarded every five years.
- Organized and hosted the MABA Gala where MABA was celebrated through the return of our first MABA President, Keith Terry, live music and great food. MABA received a Commendation from Representative Mike Bishop.

# TO OUR MEMBERS

#### Philanthropic and Golf Outing Committee:

- Raised \$1250 in funds for the Philanthropic Grants
- This year the committee received 17 nominations for the grants (a record year)
- Two grants of \$750 each were awarded

#### **Ribbon Cutting Committee:**

- Helped plan and participated in 26 ribbon cuttings and 1 VIP luncheon
- The collaboration between Meridian Township, MABA and the Lansing Chamber has evolved and we are growing vastly in the private sector.

The ultimate goal of all the efforts of our committees is to engage our members for building relationships as well as provide opportunities for prospective businesses to engage with and join MABA to gain business connections. Overall, this year has been a very successful year. We continue to look for ways to improve our meetings and our events and to bring value to our members. #### **Revenues:**

- \$31,562 cash on hand
- \$18,000 in revenue
- \$1250 raised at golf outing for Philanthropic Grants
- \$456.50 raised through 50/50 for Joan Smith Memorial Fund
- \$1500 awarded in Philanthropic Grants (MABA contributed \$250 to money raised)

#### **Expenditures:**

- \$565 awarded in grants through Joan Smith Memorial Fund
- \$1100 spent on new speaker system
- \$2400 spent to produce a video series to be used on the website and social media


